



## Marriage License Requirements

- FEES:** \$40.00 payable in cash / personal check / money order  
**OFFICE HOURS:** Monday thru Friday 8:30 a.m. to 4:30 p.m.  
**TUESDAY HOURS:** **4:30 p.m. to 7:30 p.m. By appointment**

*Marriage licenses are valid 24 hours after issuance, for a period of 60 days*

**Identification requirements: As per the New York State Division of Vital Records Two (2) Proofs of Age and Identity are required. Application MUST be submitted with originals or certified copies of one document from List A and one from List B**

- A.** One (1) of the following:
1. Birth Certificate – Original or Certified State Issued Copy
  2. Original Naturalization Document
- B. And** One (1) of the following:
1. Valid Driver's License/Valid U.S. Non-Driver's License
  2. Valid Passport
  3. Valid Immigration Record – Can be used as photo I.D. ONLY.  
**\*Does not replace Birth Certificate or Naturalization Papers.**
- C.** If divorced, ORIGINAL or SEALED CERTIFIED COPIES of divorce papers from ANY country for any and all divorces are required when applying for a marriage license, (if you were married and divorced twice you will need both sets of divorce papers). If widowed, a certified copy of the death certificate is required.
- D.** Requirements for a Second or Subsequent Ceremony License: Original or certified copy of your Marriage Transcript, the above Required Identification, and Divorce/Death Certificates (if applicable).

DOCUMENTS IN ANY LANGUAGE OTHER THAN ENGLISH MUST BE TRANSLATED BY A CERTIFIED TRANSLATOR. THE TRANSLATION MUST BE A FULL AND COMPLETE TRANSLATION OF THE ENTIRE DOCUMENT INCLUDING THE MEANING OF ANY TITLES, STAMPS OR SEAL. A SUMMARY OF THE DOCUMENT IS NOT ACCEPTABLE. THE TRANSLATION MUST INCLUDE THE TRANSLATOR'S TITLE, POSITION AND QUALIFICATIONS. THE STATEMENT MUST BE SIGNED, DATED AND NOTARIZED.

TRANSLATIONS THAT DO NOT MEET ALL OF THE ABOVE QUALIFICATIONS WILL NOT BE ACCEPTED

**Requirements for applicants age 17 – Application MUST be submitted with ALL of the following:**

1. Original Birth Certificate
2. Valid picture I.D.
3. Written consent and valid picture I.D. of **BOTH** parents
4. Written approval of a justice of the Supreme Court or of a judge of the Family Court, having jurisdiction over the town or city in which the application is made.
