

1) Single House Bill (introduced and printed separately in either or  
both houses). Uni-Bill (introduced simultaneously in both houses and printed  
as one bill. Senate and Assembly introducer sign the same copy of the bill).

1 Section 1. Subdivision (a) of section 1 of chapter 397 of the laws of  
2 1996, relating to authorizing the town of Islip to lease certain lands  
3 to a business corporation, as amended by chapter 303 of the laws of  
4 2012, is amended to read as follows:

5 (a) The town of Islip, in the county of Suffolk, is hereby authorized  
6 and empowered to extend the terms of a lease between the town and a  
7 business corporation dated July 30, 1996 that was authorized by chapter  
8 397 of the laws of 1996 on the lands described in chapter 397 of the  
9 laws of 1996 for up to [ten] ~~twenty-six~~ additional years from the date  
10 of its expiration.

11 § 2. This act shall take effect immediately.
