These samples, taken on Wednesday, May 14, confirm for the second time in two weeks, that there is absolutely **no presence of asbestos in the air** at Roberto Clemente Park.

The Town hired an independent environmental consultant, Enviroscience, within hours of learning of the information from the Suffolk District Attorney last week. Enviroscience has been to the park on two separate occasions, each time collecting a total of 16 samples from different locations around the perimeter of the site. The Town has directed Enviroscience to continue to gather air samples over the next several weeks to ensure the safety of the surrounding residents.

In a continuing effort to ensure the health, safety and welfare of all residents, Town officials have also begun an in-depth review and assessment of its entire parks' system, and has learned through preliminary tests conducted by Enviroscience that small amounts of asbestos-containing materials were discovered in a 10 ft. x 10 ft. area at the rear of Clayton Avenue fields, located on Clayton Avenue in Central Islip, where the Suffolk County Police Athletic League is currently developing multipurpose athletic fields. The Town immediately issued a Stop Work Order yesterday, and secured the fields as a precaution. Full testing results will be completed in two weeks. The Clayton Field site was part of the former Central Islip Psychiatric Center and donated to Islip Town in the mid-1970's by the State of New York. The Town has written to SC PAL to request a list of all contractors used during the project.

"The Town Board remains committed to openly communicating with the public as the details unfold, but it is critical that we ensure ALL of our parks and the people who use them, are protected. These samples, taken on Wednesday, May 14, confirm for the second time in two weeks, that there is absolutely **no presence of asbestos in the air** at Roberto Clemente Park.

The Town hired an independent environmental consultant, Enviroscience, within hours of learning of the information from the Suffolk District Attorney last week. Enviroscience has been to the park on two separate occasions, each time collecting a total of 16 samples from different locations around the perimeter of the site. The Town has directed Enviroscience to continue to gather air samples over the next several weeks to ensure the safety of the surrounding residents.

In a continuing effort to ensure the health, safety and welfare of all residents, Town officials have also begun an in-depth review and assessment of its entire parks' system, and has learned through preliminary tests conducted by Enviroscience that small amounts of asbestos-containing materials were discovered in a 10 ft. x 10 ft. area at the rear of Clayton Avenue fields, located on Clayton Avenue in Central Islip, where the Suffolk County Police Athletic League is currently developing multipurpose athletic fields. The Clayton Field site was part of the former Central Islip Psychiatric Center and donated to Islip Town in the mid-1970's by the State of New York. The Town has written to SC PAL to request a list of all contractors used during the project.

"The Town Board remains committed to openly communicating with the public as the details unfold, but it is critical that we ensure ALL of our parks and the people who use them, are protected. This is why we moved quickly to form an assessment team to methodically inspect and review each of our parks, beginning with the newest constructed projects," said Councilman Anthony Senft, Jr. "We understand and appreciate the gravity of the investigation and its ramifications, and our priority will be to make sure that Roberto Clemente is remediated and returned to the Brentwood community, while also ensuring that all of our parks are sound."

Town attorneys sent letters to the developers of two park projects requesting further details about what contractors were hired and what suppliers of materials were used during construction. The Town has also begun researching its own records to determine what, if any, Town work has been performed on these sites.

Last week, Islip terminated a Tree Trimming contract with Daytree at Cortland Square and put the firm's insurance carriers, and other carriers, on notice that their insured's were part of an ongoing investigation.

Senft also reported several other updates including the Town's lead to coordinate with representatives from the New York State Department of Environmental Control, the New York State Department of Labor, New York State Department of Health, and Suffolk County Department of Health - agencies that have the environmental or public health expertise - to assist the Town's plans for future remediation efforts at Roberto Clemente. Coordination from these government agencies is critical to ensure Clemente Park's restoration is critical.

The Town continues to regularly communicate with the public and mailed an additional 2,000 letters to residents this week within the surrounding neighborhood of the park on Wednesday. Earlier this week, the Town established a toll free, bilingual phone number that the public can call, 24-hours-a-day, to obtain the most up-to-date information about Roberto Clemente Park. Senft also provided an update to a related investigation into an alleged illegal dumping operation at 1625 Islip Avenue in Central Islip. In early April, Islip Town served property owner Tommy Lau with seven appearance tickets for several code violations related to unlawful operation of a rock crushing operation, creating motorist obstructions, failure to maintain his commercial property litter and debris, and illegal outdoor storage. Yesterday, the Town obtained a Temporary Restraining Order in Suffolk County Fifth District Court against LC Realty/Tommy Lau which restrains him from illegally using and/or occupying the premises. The property owner is due in court on June 25, 2014 and, until such time, the TRO remains effect.

Earlier this week, Islip officials submitted a request seeking more information from the New York State Department of Environmental Conservation about the state agency's investigation and related actions in January 2014 at Roberto Clemente Park after community complaints concerning unsafe material was discovered in the recharge basin.

Town officials continue to coordinate logistics for transportation of Brentwood families to a nearby public pool this summer and have scheduled meetings with Brentwood School District officials to review available facilities for potential summer programs and use of pool and gymnasium as Roberto Clemente remains closed.

## Questions and answers about asbestos and dust in outdoor air

### What is asbestos?

Asbestos is the name given to a group of fibrous minerals that occur naturally in the environment. Asbestos fibers are strong, flexible, and heat resistant and have been used over the years for a wide range of building materials and manufactured goods, among them: roofing shingles, ceiling and floor tiles, paper products, and asbestos cement products, friction products (automobile clutch, brake, and transmission parts), heat-resistant fabrics, packaging, gaskets and coatings.

### How is someone exposed to asbestos?

We are all exposed to low levels of asbestos in the air we breathe, though levels are generally higher in cities and industrial areas. Higher levels of exposure occur most often when the asbestos-containing material is disturbed during demolition work, which releases fibers into the air. Undisturbed or buried asbestos-containing materials release very few fibers into the air.

### What are the health concerns of asbestos exposure?

It is known that long-term exposure to high levels of asbestos can be harmful to human health. When invisible asbestos fibers are disturbed, they can be inhaled and lodge in the lungs. Continued exposure increases the number of fibers that lodge in the lungs. Fibers embedded in lung tissue over many years may result in lung diseases such as asbestosis, lung cancer, or mesothelioma (a type of cancer). These diseases are a risk primarily for workers exposed to high levels of asbestos for years or decades. Asbestosis and mesothelioma are very rare in people who did not work in asbestos industries. There are no immediate symptoms from exposure to asbestos. Though no level of exposure to asbestos is completely safe, the risk of disease is directly related to how much you are exposed to, how often you are exposed and for how long your exposure lasts.

### Is dust a health concern?

Soil disturbance at construction or demolition sites can produce dust particles that are made up of different materials and vary in size. Small dust particles can become airborne and can be inhaled. Whether or not asbestos is present, breathing dust can cause short-term health effects such as eye, nose, throat and lung irritation, coughing, sneezing, runny nose and shortness of breath. Exposure to high levels of very small dust particles in air can also affect lung function and worsen medical conditions such as asthma and heart disease. Visible dust that settles on outdoor surfaces such as cars or porches is made up of relatively large particles that when disturbed and inhaled do not reach the deepest parts of the lungs; however, breathing these particles can still be irritating to the sinuses and throat.

### How can I reduce my exposure to dust in and around my home?

Families can lower dust exposures by regularly cleaning the home of dust and tracked-in soil. To reduce dust exposure in homes, use damp cleaning methods. Mop floors often, and use damp cloths to clean tables, countertops and windowsills. To reduce the amount of soil that is tracked into the home, use a door mat or rug and remove your shoes when entering the home. Outdoors, damp-wipe dusty surfaces and hose down dusty shrubs and lawns to reduce the amount of surface dust that may be released into the air or enter the home on shoes.

# Preguntas y respuestas sobre asbestos y el polvo en el aire fuera de casa

## Qué es asbestos?

Asbestos es el nombre que se le da a un grupo de minerales fibrosos que ocurre naturalmente en el medio ambiente. Las fibras de Asbestos son fuertes, flexibles, y resistentes al calor y han sido utilizadas en el correr de los años en una serie de materiales de construcción y productos manufacturados, entre ellos: techos, tumbados y pisos, productos de papel, productos de cemento asbestos, productos de fricción (embrague de automóvil, frenos, y partes de transmisión), telas de resistencia al fuego, productos de empaque, uniones y revestimiento.

## Cómo alguien se expone al asbestos?

Todos nosotros estamos expuestos a bajos niveles de asbestos en el aire que respiramos, sin embargo, estos niveles son generalmente más elevados en las ciudades y áreas industriales. El exponerse a niveles más altos ocurre con más frecuencia cuando el material que contiene asbestos es alborotado durante trabajos de demolición, mismo que libera fibras en el aire.

## Cuáles son las preocupaciones de salud por causa del contacto con el asbestos?

Se conoce que el exponerse a altos niveles de asbestos por largo tiempo puede ser dañino para la salud humana. Cuando las fibras de asbestos invisible son dispersas, estas pueden ser inhaladas y refugiarse en los pulmones. El contacto continuo aumenta el número de fibras que se refugia en los pulmones. Las fibras que penetran en el tejido del pulmón puede con el pasar de los años occasionar enfermedades como asbestosis, cáncer del pulmón, o mesotelioma (un tipo de cáncer). Estas enfermedades son un peligro especialmente para trabajadores que se exponen a altos niveles de asbestos por años o décadas. Asbestosis y mesotelioma son muy raros en personas que no trabajan en las industrias de asbestos. No existen síntomas inmediatos como resultado del contacto con asbestos. A pesar de que ningún nivel de asbestos es completamente seguro, el riesgo a la enfermedad está directamente relacionada con la cantidad a la que se exponen, la frecuencia del contacto y la cantidad de tiempo que este contacto dura.

## Es el polvo una preocupación de salud?

El movimiento de tierra en los sitios de construcción o demolición produce partículas de polvo que están hechos de diferente material y tamaño. Partículas pequeñas pueden convertirse en parte del aire que respiramos y pueden ser inhaladas. Bien sea que exista asbestos o no, respirar polvo puede causar efectos de salud a corto plazo tales como irritación al ojo, nariz, garganta y pulmón, tos, estornudo, descarga por la nariz y dificultad al respirar. El contacto a altos niveles de partículas de polvo muy pequeñas en el aire pueden también afectar el funcionamiento del pulmón y empeorar las condiciones médicas tales como asma y enfermedad del corazón. El polvo visible que se asienta en las superficies exteriores tales como carros o jardines están relativamente hechas de grandes partículas que cuando se mueven o inhalan no alcanzan las partes más profundas de los pulmones, sin embargo, el respirar estas partículas pueden aún irritar la sinusitis y garganta.

## Cómo puedo reducir mi contacto al polvo dentro y alrededor de mi casa?

Las familias pueden disminuir el contacto al polvo limpiando regularmente la casa y no entrando a la casa la tierra que pisamos. Para reducir el contacto en las casas, use métodos de trapos húmedos. Lave los pisos con frecuencia, y use trapos húmedos para limpiar mesas, los mesones y bordes de las

ventanas. Para reducir la cantidad de tierra que se entra a la casa, use una alfombra o tapete y quite sus zapatos antes de entrar a la casa. En la parte de afuera de la casa, limpie con un trapo húmedo las superficies polvosas y riegue con agua los arbustos y césped ( hierba) para reducir la cantidad de polvo en la superficie que puede ser liberada en el aire o entrar a la casa en sus zapatos.



Apreciado residente:

El ayuntamiento de Islip continúa comunicándose directamente con usted en un esfuerzo para mantenerlo informado acerca de la investigación de actividad ilegal en el parque Roberto Clemente. La investigación criminal llevada a cabo por la oficina del fiscal del distrito del Condado de Suffolk, así como la investigación interna del ayuntamiento de Islip continúan. A continuación enumeramos las acciones inmediatas que el ayuntamiento tomó al enterarse de la presencia de material peligroso el 5 de mayo:

- Cerramos el parque de manera inmediata el lunes 5 de mayo, y el parque permanece cerrado durante la investigación. Se siguen tomando muestras de suelo y aire.
- En un plazo de 24 horas, el ayuntamiento de Islip se hizo con los servicios de un consultor ambiental, y por medio de éste, Enviroscience, recientemente recibimos los resultados de muestras de aire que fueron recolectadas el viernes 9 de mayo en el parque. **Los resultados muestran que no hay asbestos en el aire en ninguna de las ubicaciones en donde se recolectaron muestras.** Las muestras de aire fueron recolectadas en 16 sitios a lo largo del perímetro del parque Roberto Clemente, incluyendo la cuenca de recarga, los campos de juego y las canchas de fútbol. Pese a que los exámenes de aire no indican lo que otras muestras de suelo revelan, estos resultados de muestras de aire indican que el aire en el parque y en el barrio circundante no presenta riesgo en este momento. El ayuntamiento continuará tomando muestras de aire en el parque en las semanas siguientes, a fin de asegurar la integridad de la calidad de aire para los residentes y empleados, e informará de los resultados una vez los reciba.

- La comunicación oficial con la comunidad de Brentwood ha estado a la vanguardia de la respuesta del ayuntamiento. 

## ROBERTO CLEMENTE PARK UPDATE #3



May 13, 2014

Dear Resident,

The Town continues to communicate with you directly in an effort to keep you updated about the investigation into illegal activity at Roberto Clemente Park. The criminal investigation conducted by the Suffolk County District Attorney's office as well as the Town of Islip's own internal review continues. The following are the immediate actions that the Town took upon learning about the presence of hazardous material on May 5th:

- We shut down the park immediately on Monday, May 5<sup>th</sup>, and the park remains closed during the investigation as soil and air sampling continues.
- Within 24 hours the Town of Islip retained the services of an environmental consultant, and through this consultant, Enviroscience, recently received the results of air samples that were collected on Friday, May 9th in the park. **The results have shown that there is no asbestos in the air from all locations where samples were collected.** Air samples were collected at 16 sites along the entire perimeter of Roberto Clemente Park, including the recharge basin, ball fields, and soccer fields. While testing of the air does not indicate what other soil sampling may reveal, these air sample results indicate that the air in the park and the surrounding neighborhood does not present a risk at this time. The Town will continue to sample the air at the park over the coming weeks to ensure the integrity of the air quality for residents and employees and report the results as they are received.
- During the Town's review it became evident that the Parks Commissioner was derelict in his duties and we can now see that relying on his judgment alone was wrong. The Town sought and successfully received his resignation within 48 hours of our meeting with the District Attorney, and we have since terminated another negligent employee. Additional personnel changes may occur as the Town's review continues.
- Official communication with the Brentwood community has been at the forefront of the Town's response. Updates will continue through the news media, the Town website [www.townofislip-ny.gov](http://www.townofislip-ny.gov), the Town's E-alert program on the homepage of the website, through email at [supervisorsoffice@townofislip-ny.gov](mailto:supervisorsoffice@townofislip-ny.gov), social media, by door-to-door handouts and direct mail, and will also make updates available by calling **1-888-674-7501**.
- The Town will continue to search our records and fully cooperate with the Suffolk DA, providing any and all pertinent information that will result in the prosecution of all those involved in these unauthorized acts.
- The Town has also voided its Tree Trimming contract with the vendor in question and is seeking the immediate replacement of the Chairman of the Plumber's Examining Board who may be connected to

the activity the District Attorney is investigating. The Town has also put this vendor's insurance carriers on notice.

- We have directed our law department to move forward with any and all civil litigation against those deemed criminally responsible by the District Attorney.
- The Town has already begun the early planning for remediation of the park, which will involve NYS Department of Environmental Conservation and the Suffolk County Health Department.
- The Town has committed to providing transportation this summer for families to attend a nearby public pool. The Town has also been in contact with the Brentwood School District and will be engaging in discussions for possible summer activities at the school facilities. More details will follow as logistical plans are being coordinated.
- As promised, the Town remains committed to improving and rehabilitating Roberto Clemente pools. Close to \$2 million in funds earmarked for this project, will remain dedicated to the rehabilitation of the pool, its filtration system, and the eventual construction of a new spray park.
- We are committed to communicating with you along the way and ask for your understanding and patience as all of us gain a better understanding of what has happened in our park, who committed these acts, and what information you should be aware of as the investigation continues.







El ayuntamiento continuará tomando muestras de aire en el parque en las semanas siguientes, a fin de asegurar la integridad de la calidad de aire para los residentes y empleados, e informará de los resultados una vez los reciba.
- Durante el estudio del ayuntamiento se hizo evidente que el comisionado de parques fue negligente con sus obligaciones y ahora nos damos cuenta que confiar en su juicio únicamente fue algo equivocado. El ayuntamiento buscó y recibió con éxito su renuncia al cabo de 48 horas de nuestra reunión con el fiscal del distrito, y desde entonces hemos terminado el contrato de otro empleado negligente. Pueden presentarse cambios adicionales de personal en tanto el estudio del ayuntamiento avanza.
- La comunicación oficial con la comunidad de Brentwood ha estado a la vanguardia de la respuesta del ayuntamiento. Continuaremos actualizando a través de los medios de comunicación, el sitio web del ayuntamiento, [www.townofislip-ny.gov](http://www.townofislip-ny.gov), el programa de alertas electrónicas en la página de inicio del sitio web, a través del correo electrónico [supervisoroffice@townofislip-ny.gov](mailto:supervisoroffice@townofislip-ny.gov), redes sociales, folletos puerta a puerta y correo directo, y también tendremos actualizaciones disponibles en la línea **1-888-674-7501**.

- El ayuntamiento seguirá buscando en nuestros registros y cooperando íntegramente con el fiscal del distrito de Suffolk. Proporcionaremos toda la información pertinente que redunde en el procesamiento de todos aquellos involucrados con estos actos no autorizados.
- Asimismo, el ayuntamiento ha anulado su contrato de poda de árboles con la compañía en cuestión, y busca el reemplazo inmediato del director de la junta examinadora de plomería, quien puede estar conectado con la actividad que el fiscal del distrito investiga. El ayuntamiento también ha notificado a las compañías de seguro de dicha compañía.
- Hemos instruido a nuestro departamento legal para que siga adelante con todos los procedimientos civiles contra aquellos considerados criminalmente responsables por el fiscal del distrito.
- El ayuntamiento ya ha comenzado la planeación anticipada del saneamiento del parque, que ha involucrado al Departamento de Conservación Ambiental del Estado de Nueva York y al Departamento de Salud del Condado de Suffolk.
- El ayuntamiento se ha comprometido a proporcionar transporte este verano para que las familias asistan a una piscina pública cercana. El ayuntamiento también se ha puesto en contacto con el Distrito Escolar de Brentwood y estará participando de charlas sobre posibles actividades de verano en las instalaciones de las escuelas. Proporcionaremos más detalles en tanto los planes logísticos se coordinan.
- Tal y como lo prometimos, el ayuntamiento continúa con su compromiso de mejorar y rehabilitar las piscinas del parque Roberto Clemente a través de mejoramientos en la piscina. Casi 2 millones de dólares en financiación se asignaron a este proyecto, y continuarán dedicados a la rehabilitación de la piscina, su sistema de filtración y la construcción eventual de un nuevo "spray park".
- Estamos comprometidos a mantener el contacto a lo largo del camino y pedimos su comprensión y paciencia en tanto todos comprendemos mejor lo que ha sucedido en nuestro parque, quién cometió estos actos y de qué información debe estar usted pendiente a medida que la investigación continúa.



## ROBERTO CLEMENTE PARK UPDATE #3

May 13, 2014

Dear Resident,

The Town continues to communicate with you directly in an effort to keep you updated about the investigation into illegal activity at Roberto Clemente Park. The criminal investigation conducted by the Suffolk County District Attorney's office as well as the Town of Islip's own internal review continues. The following are the immediate actions that the Town took upon learning about the presence of hazardous material on May 5th:

- We shut down the park immediately on Monday, May 5<sup>th</sup>, and the park remains closed during the investigation as soil and air sampling continues.
- Within 24 hours the Town of Islip retained the services of an environmental consultant, and through this consultant, Enviroscience, recently received the results of air samples that were collected on Friday, May 9th in the park. **The results have shown that there is no asbestos in the air from all locations where samples were collected.** Air samples were collected at 16 sites along the entire perimeter of Roberto Clemente Park, including the recharge basin, ball fields, and soccer fields. While testing of the air does not indicate what other soil sampling may reveal, these air sample results indicate that the air in the park and the surrounding neighborhood does not present a risk at this time. The Town will continue to sample the air at the park over the coming weeks to ensure the integrity of the air quality for residents and employees and report the results as they are received.
- During the Town's review it became evident that the Parks Commissioner was derelict in his duties and we can now see that relying on his judgment alone was wrong. The Town sought and successfully received his resignation within 48 hours of our meeting with the District Attorney, and we have since terminated another negligent employee. Additional personnel changes may occur as the Town's review continues.
- Official communication with the Brentwood community has been at the forefront of the Town's response. Updates will continue through the news media, the Town website [www.townofislip-ny.gov](http://www.townofislip-ny.gov), the Town's E-alert program on the homepage of the website, through email at [supervisorsoffice@townofislip-ny.gov](mailto:supervisorsoffice@townofislip-ny.gov), social media, by door-to-door handouts and direct mail, and will also make updates available by calling **1-888-674-7501**.
- The Town will continue to search our records and fully cooperate with the Suffolk DA, providing any and all pertinent information that will result in the prosecution of all those involved in these unauthorized acts.
- The Town has also voided its Tree Trimming contract with the vendor in question and is seeking the immediate replacement of the Chairman of the Plumber's Examining Board who may be connected to

the activity the District Attorney is investigating. The Town has also put this vendor's insurance carriers on notice.

- We have directed our law department to move forward with any and all civil litigation against those deemed criminally responsible by the District Attorney.
- The Town has already begun the early planning for remediation of the park, which will involve NYS Department of Environmental Conservation and the Suffolk County Health Department.
- The Town has committed to providing transportation this summer for families to attend a nearby public pool. The Town has also been in contact with the Brentwood School District and will be engaging in discussions for possible summer activities at the school facilities. More details will follow as logistical plans are being coordinated.
- As promised, the Town remains committed to improving and rehabilitating Roberto Clemente pools. Close to \$2 million in funds earmarked for this project, will remain dedicated to the rehabilitation of the pool, its filtration system, and the eventual construction of a new spray park.
- We are committed to communicating with you along the way and ask for your understanding and patience as all of us gain a better understanding of what has happened in our park, who committed these acts, and what information you should be aware of as the investigation continues.
