1. Term of License

This license is effective for one year from the date indicated on the license agreement hereof and the licensed items are at all times to remain the property of REAL PROPERTY TAX SERVICE AGENCY ("County Licensor"), and the TOWN OF ISLIP DEPARTMENT OF PLANNING ("Town Licensor"); together known as ("Licensors").

2. Renewal

It is anticipated that a new edition will be available annually. However, because of publishing requirements, delivery dates may vary somewhat. This lease will terminate one year from the date indicated on the license agreement.

3. Licensee's Obligation on Termination

On the termination of this license, Licensee shall return all licensed materials to the Town Licensor at the Department of Planning, whether or not the Licensee renews this license. If Licensee fails to return the materials, Licensee shall be obligated to pay the renewal charge for the next annual edition.

4. Assignment and Copies

Licensee may not assign this edition without Licensors written agreement. Licensee may duplicate or copy portions of the licensed material for its use, but may not duplicate any materials so as to compete directly or indirectly with the products or services being offered by the Licensors.


