**WHEREAS**, Community Ambulance Company, Inc. has been providing emergency ambulance services to the residents and persons in the Sayville Community Ambulance District pursuant to a contract which will expire on December 31, 2022;

**WHEREAS**, Community Ambulance Company, Inc. is requesting that their 2022 Contract be amended retroactively from January 1, 2022 through December 31, 2022;
